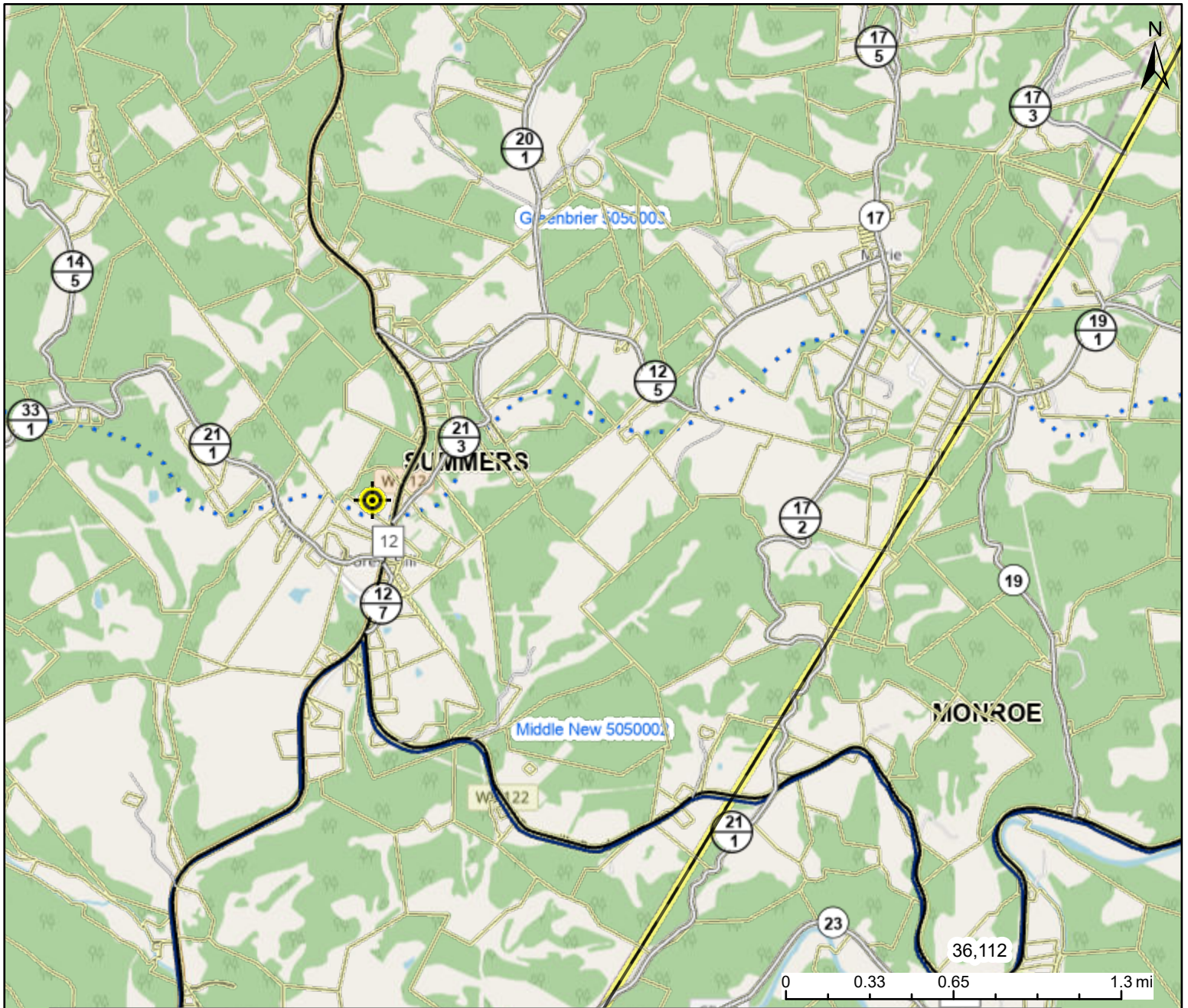







# Street map for the Smith Farm
